#### Vocational Education and Training for Schools

Maroon OEC is registered with ASQA. Because the Centre has no permanently enrolled students, schools are able to utilise MOEC to deliver part of the full certificate. QCE banking or credit is not available through MOEC. It is only available if your school is registered as an RTO to deliver a sport, fitness or outdoor recreation certificate through the QCAA. The school will also need to complete a third party agreement with the Centre to fullfil ASQA requirements of the school RTO.

# Single Course (1 week) Programs

MOEC only offers VET through the courses outlined on this document. Schools can book the Centre for a single course from the overview. This courses and corresponding MOEC program are suitable for the school based Recreation Studies subject (or similar).

Only partial training is conducted during any MOEC VET course of 4 or 5 days. It is vital that schools adequately prepare students through engagement in outdoor recreation activities and lessons prior to coming to the Centre. Unprepared or inexperienced students may have difficulty attaining competence in the course units during these short MOEC programs.

Schools must use the Centre's booking application process and clearly identify which VET course they intend to pursue.

# **Preparation for VET at MOEC**

It is vital that schools adequately prepare students through engagement in outdoor recreation activities and lessons prior to coming to the Centre. MOEC has resources for each course available via "The Learning Place Ed Studios". Your MOEC coordinator will provide an access key for a course's studio.

Schools booked for a VET program must provide students with the VET enrolment documents and forms provided by the Centre prior to or at the start of program.

### **Statement of Attainment**

Students who successfully complete their course can be issued a "Statement of Attainment" outlining the units in which they have been assessed as competent.

#### Support for VET in Schools

New standards for RTOs will need to be implemented by schools in 2015. There are new restrictions and requirements for the validation of training and assessment tools. MOEC is an Outdoor Recreation Industry business and RTO. MOEC has "**industry experts**" available to assist any school delivering the Certificate 2 in Outdoor Recreation SIS20419 with validation and other VET implementation requirements such as; VET health checks, handover to new staff checks and pre-audit checks.

# **Course Structure**

MOEC offers 5 courses to senior phase students. Each course is matched to a 5 day program based at the Centre. It is recommended that the school support these courses with a program of targeted class based instruction. Each course should form the core of a term in the school course. The school would need to cover industry and work experience to deliver the requirements of the full certificate.

# Course 1: Outdoor recreation industry experience program

No units assessed in this course. Field based program containing 2 or 3 of the activities below allowing for initial activity skills development or final assessment by the school. Campout is a vital core component of the program. Student portfolio and log book completion is a recommended feature of the program to meet assessment requirements of the core units.

# Course 2: Bushwalking-partially delivered and assessed by MOEC

SISOBWG2001 Bushwalk in tracked environments SISOFLD006 Navigate in tracked environments

Course 3: Paddling - partially delivered and assessed by MOEC

SISOCNE001 Paddle a craft using fundamental skills

Course 4: Abseiling - partially delivered and assessed by MOEC

### Course 5: Climbing - partially delivered and assessed by MOEC

### **Notes**

- 1. Schools can only book for a single course during any school week for a minimum of 4 days (preferably 5).
- 2. MOEC will develop all instructional and assessment materials for courses 2 to 5 for use at MOEC.
- **3.** School must prepare students through classroom instruction and practical sessions prior to any course. Inexperienced students may have difficulty demonstrating competence by the end of a course. Training delivered by the school to industry standards is an investment in high levels of student achievement.
- **4.** Each student must keep a logbook for each activity area (bushwalking and camping log, canoeing log, abseiling log), as a record of industry engagement. This logbook is submitted and used as evidence for final assessment. Portfolio development is recommended for students to collect investigative tasks.
- 5. Assessments can be finalised up to 12 months after a course at MOEC.

#### **Course Details**

**Course 2:** minimum of 4 days bushwalking skills instruction and assessment based at MOEC venues. School to prepare students for this course by taking students bushwalking on grade 2 and 3 tracks for at least 2 days prior to MOEC program.

**Course 3**: minimum of 4 days paddling instruction and assessment based at MOEC venues. School to prepare students for this course by paddling on flat water for at least 2 days prior to MOEC program.

**Course 4**: minimum of 4 days abseiling instruction and assessment based at MOEC abseiling venues. School to prepare students for this course by participating in abseiling for at least 2 days prior to MOEC program.

**Course 5**: minimum of 4 days climbing instruction and assessment based at MOEC climbing venues. School to prepare students for this course by attending an indoor gym for at least 2 day prior to MOEC program.
